The Group believe that the guidance of 29th August 2014 was overestimated by circa GBP 250m and have engaged Deloitte LLP to investigate the full extent of this issue prior to the release of their interim results, which has been pushed back to 23rd October 2014. It was further reported in the National Press that four Directors of tesco Plc have been requested to step aside from the Board following the disclosure and that shares in the company fell by circa 11.3 percent at the opening of trading. |

It was further reported that, due to the SFO investigation, the Financial Conduct Authority will immediately end its investigation of Tesco.

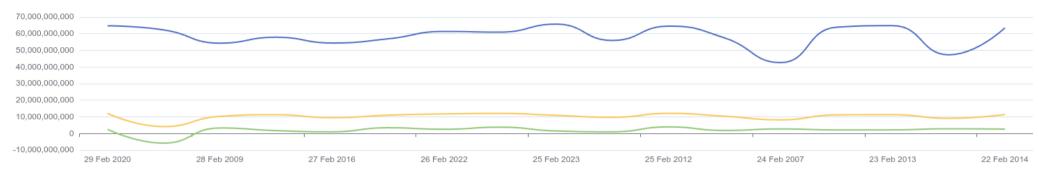

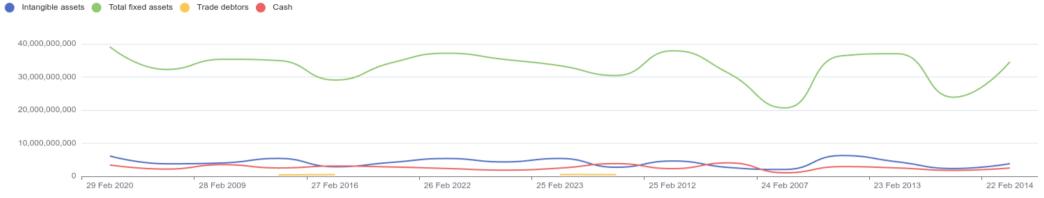

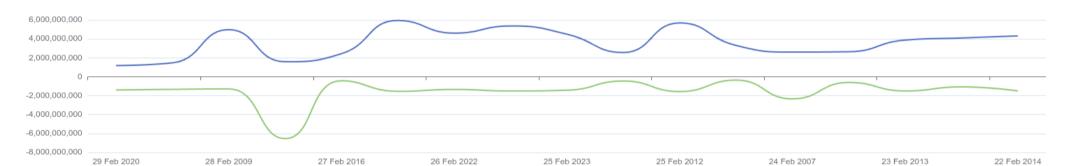
